## **ZRA announces the deployment of its online Training Certificate Program and strategic partnership with San Diego Zoo Global Academy**

The Zoological Registrars Association (ZRA) announces its new online Training Certificate Program will be available 22 October 2018. The Training Certificate Program is comprised of 6 modules covering the core duties and established competencies of the zoological registrar role:

**Module 1:** History and Established Tenets of Animal Records

**Module 2:** Records and Information Management (RIM)

**Module 3:** Transactions

**Module 4:** US Federal Wildlife Permits and Regulations

**Module 5:** Live Animal Logistics

**Module 6:** Biological Samples and Biofacts

Each module has an exam to determine the Learner's proficiency and level of comprehension and trainees will receive a Certification of Completion upon passing exams for each module and/or the entire program.

With the expanding scope of records management and legal reporting requirements within the animal care profession, a call to action for knowledge transfer through an accessible, affordable and comprehensive training program for this business need has been answered by ZRA.
